# FIGHTING DRUGS AND CRIME: A PRIORITY FOR COOPERATION OF KAZAKHSTAN WITH THE UN



Kazakhstan Kairat Umarov, during a working trip to Almaty, held talks with the leadership of the regional office of the United Nations Office on Drugs and Crime (UNODC) and the Central Asian Regional Information and Coordination Centre for combating illicit trafficking of narcotic drugs, psychotropic substances and their precursors (CARICC), reports Delovoy Kazakhstan.

During the consultations of K. Umarov with the Regional Representative of UNODC in Central Asia Ashita Mittal, the priorities of cooperation in the field of countering the Afghan drug threat, strengthening borders, preventing radicalization in prisons, as well as the return of property and income obtained illegally were discussed. The interlocutors stressed that the UNODC technical assistance programs in Central Asia should be aimed at achieving practical results in accordance

with the national priorities of the countries of the region, both in the field of security and socio-economic development.

At a meeting with acting CARICC Director Atageldy Yazlyev discussed the current trends in drug trafficking in the region and ways to further develop the center, taking into account the results achieved in conducting anti-drug operations and analytical studies over the past 15 years. Following the meeting, the parties agreed on further coordination in strengthening

# THE NUMBER OF CRIMINAL OFFENSES RELATED TO DRUG TRAFFIC REDUCED BY 9%

The number of criminals caught in such offenses decreased by 5%.

In January-September of this year, 5.7 thousand criminal offenses related to the illegal circulation of narcotic drugs, psychotropic or poisonous substances, their analogues and precursors were registered in the country, which is 8.7% less than a year earlier.

Two-thirds of all offenses fell on the illegal handling of narcotic drugs without the purpose of sale: 3.8 thousand cases, immediately minus 12.8% per year.

Such offenses for the purpose of sale were also frequently registered (1.3 thousand cases, minus 2% per year) and cases of cultivation of plants containing narcotic substances prohibited from cultivation (283 cases, plus 14.6%).

In the course of detecting offenses, 728 vehicles, 19.1 thousand weapons, 297 extremist materials, 38 forged documents, as well as property, money

and valuables totaling 1.1 billion tenge were seized from violators.



In the regional context, offenses related to illicit trafficking in narcotic drugs, psychotropic or poisonous substances, their analogues and precursors were most often registered in the capital: 624 cases since the beginning of the year - 30% less than a year earlier. Almaty (515 cases, minus 11.5%) and Zhambyl region (503 cases, minus 14.2%) were on the second and third lines of anti-leadership.

A noticeable increase in the number of offenses was noted in the Aktobe region (plus 33.3%, up to 308 offenses), the largest reduction was in the capital.

Over the nine months of this year, 3.2 thousand people were caught on criminal offenses related to illegal circulation of narcotic psychotropic or poisonous substances, analogues and precursors, which is 4.7% less than a year earlier. Among them, 204 people had previously committed offenses. 133 offenders are women, 18 offenders are minors. Most of the criminals are citizens of the Republic

Kazakhstan, and among those who violated the law were 140 citizens from the CIS countries, including 55 citizens of Uzbekistan, 48 citizens of Russia, 22 citizens of Kyrgyzstan, 4 citizens of Tajikistan, 2 citizens of Turkmenistan.

73% of offenders were caught illegally handling drugs without the purpose of sale.

Meanwhile, the number of people who committed criminal offenses under the influence of drugs and toxic substances has decreased by a noticeable 28.8% since the beginning of the year, to 569 people.

A draft Comprehensive Plan to Combat Drug Addiction and Drug Business is being developed in the Republic of Kazakhstan, the Ministry of Internal Affairs of the Republic of Kazakhstan reports.

The project involves coordination of efforts in three main areas:

- improvement of the drug control mechanism, simplification of the procedure for placing new psychoactive substances under state control;
- material and technical equipment of state bodies, especially institutes of forensic examinations and public health authorities;

# IN KAZAKHSTAN LIQUIDATED IN 10 MONTHS 11 INTERNATIONAL DRUG TRAFFIC CHANNELS



In Kazakhstan, from July to October of this year, 36 antidrug operations were carried out, including jointly with partners from Russia, Uzbekistan and Kyrgyzstan, the National Security Committee of the Republic of Kazakhstan reported.

11 international and 14 regional drug trafficking channels have been liquidated. The activities of 4

clandestine laboratories for the production of synthetic drugs have been neutralized," the committee's website says.

During special operations, 59 members of drug structures were detained. More than 282 kg of drugs were seized from illegal circulation, including 32 kg of heroin, 11 kg of opium, 60 kg of synthetic drugs, 156 kg of marijuana, 22 kg of hashish. In addition, 861 ecstasy tablets and more than 3 tons of chemical reagents intended for the manufacture of psychotropic substances have been withdrawn from circulation, the department noted.

Measures to counter the international drug business continue.

The objectives of such events are the formation of skills for independent decision-making, the promotion of legal knowledge, the development of the ability to work in a group, express one's views, and lead a discussion.

## RUSSIAN SCHOOLS PROPOSED TO INTRODUCE MANDATORY DRUG TESTING



Mandatory drug testing was proposed to be introduced in the Khabarovsk Territory. At a thematic meeting of teachers, parents and doctors, the initiative was voiced against the backdrop of the growing scale of narcotization of minors and the growth of adolescent mortality from psychoactive substances, Izvestia writes.

To date, testing in schools is most often carried out by health workers with the involvement of psychologists - after the conversation, the teenager is invited to undergo an in-depth examination. May go as far as giving urine samples for testing for drug markers.

At a meeting of the anti-drug commission of the Samara region a few days ago, they noted the positive experience of socio-psychological testing.


"I consider testing very important and necessary, it should definitely be carried out in schools. At least as a deterrent, a psychological barrier. They should know and understand that at any time the school can be tested for drugs, traces of which can remain in the blood for more than 30 days," commented State Duma deputy, head of the Sober Russia project Sultan Khamzaev.

At the same time, he noted that there should be a program for the rehabilitation of drug addicted children, which is currently absent in the country.

## PHARMACY ADDICTION IS UNDER SPECIAL CONTROL OF THE MANAGEMENT OF THE DON REGION



The prevention of drug addiction associated with non-medical consumption of drugs was discussed at a meeting of the regional anti-drug commission chaired by Governor Vasily Golubev. This was reported by the press service of the head of the region.

- The problem of "pharmacy drug addiction" requires constant attention. In addition to regular inspections of pharmacy chains, monitoring compliance with bans on remote sale of drugs, legislative regulation of this area is also required, the report says.

The Don departments have prepared proposals for improving legislative measures to combat "drug addiction". We are talking about a strict quantitative accounting of drugs, the introduction of new forms of prescription forms. There is also a social component to this work: involving representatives of public organizations in conducting test purchases, in monitoring specialized sites for the online sale of medicines, and in prevention among adolescents and young people.

- In addition to solving large-scale problems in this area, it is necessary to explain the negative consequences of non-medical consumption of psychoactive drugs for human health. Pay special attention to preventive work with teenagers and young people, - said Vasily Golubev.

The participants of the meeting were unanimous in their opinion that it is important to organize close cooperation in this direction among all institutions and bodies of prevention, including commissions for minors and the protection of their rights, divisions for minors of the territorial bodies of the Ministry of Internal Affairs, penitentiary inspections.

"If necessary, we need to help these guys get an education or find a job," the governor said.

# HEAD OF DCA TOLD UN REPRESENTATIVE ABOUT THE SITUATION WITH THE SEIZURE OF DRUGS IN TAJIKISTAN

At the beginning of the meeting, the Director of the Agency acquainted the guests with the results of the activities of the law enforcement agencies of the republic, including the Agency, in the field of drug seizure.

According to the press service of the Agency, the head of the anti-drug department informed about the situation with the fight against drugs in the regions of Tajikistan bordering Afghanistan.

It was stressed that the situation is still worrying, and since the Taliban came to power, the intensity of drug seizures in these regions tends to increase.

The Director of the Agency made a number of proposals to strengthen the fight against drug trafficking, especially in the border areas, by creating new departments and equipping them with the necessary equipment and supplies.

Thus, the purchase and possession of up to 30 grams of marijuana for personal recreational consumption will not be penalized. Its cultivation will be allowed to a limited extent.

At the government meeting, Lauterbach was supposed to present a survey according to which about 4 million adults in Germany use marijuana. The data indicate the existence of a large-scale black market and organized crime, the publication noted.

In a coalition agreement, the German Social Democratic Party (GSD), the Green Party and the Free Democratic Party (FDP) agreed to introduce "controlled distribution of adult cannabis for consumption through licensed shops".

However, the publication noted that the rules of the European Union on the treatment of cannabis may interfere with its legalization in Germany, because the international legal framework offers "limited opportunities for the implementation of the coalition project."

That is, the relevant bill must first be evaluated by the EU and can be considered by the German parliament only if it does not receive legal objections from the European Union. The coalition is expected to present the bill late this year or early next year, but its final version will depend on the EU's assessment.
